

2025 Eurolux Elf on a Shelf Competition – Terms & Conditions

Competition Period: 1 December – 24 December 2025

These Terms and Conditions (“T&Cs”) govern the 2025 Eurolux Elf on a Shelf Competition (“the Competition”). By entering, all participants agree to be bound by these T&Cs.

1. Promoter

The Competition is organised and conducted by Eurolux (Pty) Ltd (“the Promoter”), registration number 2000/019019/07, with its principal place of business at 72, 5th Street, Wynberg, Sandton, Johannesburg, South Africa.

2. Competition Period

The Competition runs from 1 December 2025 to 24 December 2025.
Entries received after 24 December 2025 at 23h59 will not be considered.

3. Stores Participating

This Competition is valid only at selected participating retail stores across South Africa that stock Eurolux products.
A full list of participating stores is available on request.

4. Who May Enter

- The Competition is open to South African residents aged 18 years or older.
- **The following persons may not enter the Competition:**
 - Directors, members, partners, employees, agents, or consultants of the Promoter;
 - Any suppliers or third-party service providers involved in administering the Competition;
 - Immediate family members (spouses, parents, siblings, children) of the above persons;
 - Employees, management, and immediate family members of the Eurolux Group, any associated or affiliated businesses, and the staff, management, owners, and agents of participating retail stores.

The Promoter reserves the right to request proof of eligibility at any time.

5. How to Enter

Participants may enter via either one or both of the following methods.

ENTRY METHOD 1: Buy Any Eurolux Product & Stand a Chance to Win R2,000 Cash

How to enter:

1. Purchase any Eurolux product from a participating store during the Competition Period.
2. Keep the original till slip as proof of purchase.
3. WhatsApp a clear photo of the till slip to 076 391 3933, or scan the in-store QR code to access the WhatsApp entry channel.
4. Each valid till slip counts as one entry into the weekly draw.

Prizes:

- 5 winners per week, each receiving R2,000.
 - Total of 20 winners over the Competition Period.
 - Winners will be selected by randomised draw, overseen and verified by an independent auditor/attorney, in accordance with CPA requirements.

ENTRY METHOD 2: Spot the Elf on the Shelf – Win R5,000 Weekly

How to enter:

1. Locate the Eurolux Elf on the Shelf display at a participating store.
2. Take a selfie (“Elfie Selfie”) with the Elf.
3. Upload the selfie to Facebook, tagging @Eurolux.
4. Each participant may submit one selfie per week.

Prizes:

- 1 winner per week, receiving R5,000.
 - Total of 4 winners.
 - Winners will be selected by randomised draw, overseen and verified by an independent auditor/attorney.

6. Weekly Draws

- Weekly draws will take place on or after:
 - 8 December 2025
 - 15 December 2025
 - 22 December 2025
 - 24 December 2025
- All draws will occur within five (5) business days after each weekly cut-off.
- Draws will be randomised, independently supervised, and verified to ensure compliance with the Consumer Protection Act.

7. Winner Notification

- Winners will be notified via mobile phone call (Entry Method 1) or via Facebook message and/or requested contact details (Entry Method 2).
- The Promoter will make three (3) attempts to contact a winner over 48 hours.
- If contact cannot be made within this period, the winner will be disqualified, and a new winner will be drawn.
- Winners may be required to provide:
 - Proof of identity (ID/Passport/Driver's Licence);
 - Original till slip (Entry Method 1);
 - Proof of South African bank account in their name;
 - Any other reasonable verification documents.

Failure to supply required documents may result in disqualification.

8. Prize Details & Payment

- All prizes are cash and paid via EFT into a South African bank account in the winner's name.
 - Once all verification documents have been received and approved, payment will be made within 5 (five) working days.
 - Prizes are non-transferable, non-exchangeable, and cannot be substituted for any other item or benefit.
 - Prizes must be claimed within 30 days of notification.

9. POPIA & Privacy

- By entering the Competition, participants consent to the Promoter processing their personal information solely for purposes of conducting and administering the Competition, in line with the Protection of Personal Information Act (POPIA).
 - Personal information will not be shared with third parties except where necessary for winner verification or prize fulfilment.
 - Winners will be asked for optional consent to allow the Promoter to publish their name and/or winning entry for marketing purposes. Declining will not affect their eligibility or receipt of the prize.

10. Disqualification

The Promoter reserves the right to disqualify any participant who:

- Provides false, inaccurate, or misleading information;
- Submits illegible, altered, incomplete, or fraudulent till slips;
- Uses automated or duplicate accounts, bots, or fake profiles;
- Uploads offensive, inappropriate, misleading, or non-compliant selfie content;
- Attempts to interfere with or manipulate the Competition.
- Has by good fortune previously won more than once in either the R5000 or R2000 draw over the four week period.

The Promoter's decision regarding disqualification is final.

11. General

- Participation is free, except for standard mobile data or network charges.
 - Purchasing a Eurolux product does not increase the probability of winning. Each valid entry counts equally.
 - The Promoter may amend, suspend, or cancel the Competition if necessary due to circumstances beyond its control, subject to applicable law.
 - The Promoter's decision on all aspects of the Competition is final, and no correspondence will be entered into.
